The Deputy Minister of Railways (Shri Shahnawaz Khan); (a) and (b) The maximum permissble speed of trains on this section is 35 miles per hour, but this is restricted to 30 miles per hour over a continuous of about 24 miles up to Narsapur, due to heavy wear of track rails. work of relaying track which is already included, in parts, in the Works Programme of the current and the next two years, is expected to be completed by 1960-61, when the maximum speed of 35 miles per hour will be restored throughout the section

 - (4) Four urinals flush type on Narrow Gauge platform.
 - covered shed on passenger platform is programmed for 1958-59.

 - (ii) Additional Telegraph Offices 280
 - (iii) Additional Long distance Public Call Offices 240
- (iv) Additional Telephones 36,000.

The schemes taken up this year are expected to meet those targets. the extent equipments and materials
