#### Liaison Officers in B.E.L. Bangalore

1702. SHRI RAM PYARE PANIKA : Will the Minister of DEFENCE be pleased to state :

(a) who has been the Liaison Officer for SC/ST employees in B. E. L., Bangalore during the last five years; whether the incumbent belonged to SC/ST; and

(b) what is the duty of the Liaison Officer?

THE MINISTER OF STATE IN THE MINISTRY OF DEFENCE (SHRI SHIVRAJ V. PATIL) : (a) S. Subbarayan, Shri Manager (Personnel & Industrial Relations) and Shri B. C. Ananthapadmanabha, Deputy Manager (Industrial Relations) had been the Liaison Officers in Bharat Electronics Ltd., Bangalore during the last five years, in respect of matters relating to the representation of Scheduled Castes & Scheduled Tribes. They do not belong to SC/ ST community.

(b) As per the Presidential Directives issued to BEL, the Liaison Officer is specifically responsible for :

- (i) Ensuring due compliance with the orders and instructions pertaining to the reservation of vacancies in favour of Scheduled Castes and Scheduled Tribes and other benefits admissible to them under the Directives.
- (ii) Collecting, consolidating and despatching the annual returns relating to representation of
  - Scheduled Castes and Scheduled Tribes.
- (iii) Acting as a Liaison Officer between the Undertaking and the Ministry concerned for supply of other information, answering questions and que-

- ries and clearing doubts in regard to matters covered by these orders.
- (iv) Conducting annual inspection of the rosters maintained in the enterprise with a view to ensuring proper implementation of the reservation orders.
  - (v) Ensuring that the normal administrative inspections which are carried out periodically, give assessment of the performance of the enterprise in the matter of strict observance of orders regarding the reservation for Scheduled Castes and Scheduled Tribes and in filling vacancies reserved for these communities.

### Inclusion of 'Kudbi Community' in Karnataka in Scheduled Castes

1704. SHRI OSCAR FERNAN-DES: Will the Minister of HOME AFFAIRS be pleased to state:

(a) whether there is a representation from the 'Kudbi Community' in Karnataka to he declared as Scheduled Tribe; and (b) if so, the action, Government of India have taken in this regard ?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI YOGENDRA MAKWANA) : (a) Representations have been received for the inclusion of 'Kudbi Community' in the list of Scheduled Tribes in Karnataka.

(b) The above proposal as well as many other such proposals in respects of all the States/Union Territories are being duly considered in the context of the proposed comprehensive revision of the lists of Scheduled Castes and Scheduled Tribes in consultation with the concerned State Governments including that of Karnataka and with the Registrar General of India.

#### M/s. Hindustan Lever at biggest Soap Manufacturing Company

1705. SHRI INDRAJIT GUPTA: Will the Minister of INDUSTRY be pleased to state :

(a) whether Hindustan Lever, a subsidiary of Uni Lever, U.K. is the biggest soap manufacturing company in the country;

(b) whether reservation of laundry soap for the small scale sector carries any meaning if Hindustan Lever has enjoyed or continues to enoy unlimited capacity for soap production;

(c) if so, the details of the meaning attached to such reservation; and

(d) if not, the reason for permitting Hindustan Lever such preferential treatment at the expense of small scale sector in the country?

THE MINISTER OF STATE IN THE MINISTRY OF INDUSTRY (SHRI CHARANJIT CHANANA): (a) to (d). M/s. Hindustan Lever Limited is the biggest soap manufac-

turing company in the country. They hold Registration Certificates issued in 1954 under Section 10 of the Industries (Development & Regulation) Act, 1951 for the manu-facture of "Soaps". As per the policy followed then, no capacity has been indicated in the Registration Certificates. The manufacture of laundry soap was reserved for exclusive development in the small scale sector in 1966. After the reservation so made, no expansion in the manufacture of laundry soap has been granted to this company. The question of endorsement of specific capacity in the Registration Certificates for this product is under con-sideration of Government as per policy in force.

## Manufacture of Mopeds by Scooters' Kerala Ltd.

(a) whether State-owned Scooters Kerala Ltd. of Kerala has been given a ligence: to manufacture mopeds with foreign collaboration;
