#### Statement

The horizontal axis, multi-directional water pumping windmill has a rotor diameter of 5 metres, and consists of 12 metal blades. The pump is of the single acting reciprocating type. The height of the tower is 6 metres. The windmill is capable of operating in regions having average windspeeds of 8 km/hr; it provides a total lift of about 6 metres, and the discharge of water is nearly 2500 litres/hr. These windmills are promising for pumping water for minor irrigation or drinking, or for pumping brine into salt pans. The cost of each unit is estimated at about Rs. 12,000.

Similar water pumping windmills have been developed at the Institute of Engg. and Rural Technology, Allahabad; a number of such units are being installed at several locations for demonstration and fieldtesting.

THE MINISTER OF STATE IN THE MINISTRY OF DEFENCE (SHRI SHIVRAJ V. PATIL) : (a) and (b). During 1981, propo-sals suggesting the opening of Sainik Schools have been received from the Governments of Arunachal Pladesh, Bihar, Karnataka, Maharashtra and Tripura. These Governments have been informed of the requirements which have to be met by them before Government of India can take up an examination of the matter. The Governments of Bihar. Karnataka and Maharashtra have not revived their proposals. The Government of Arunachal Pradesh and Tripura have sought further information in the matter, which is being supplied.
