Puri Hotel

THE DEPUTY MINISTER IN THE MINISTRIES OF RAILWAYS AND EDUCATION AND SOCIAL WEL-FARE AND DEPARTMENT OF PAR-LIAMENTARY AFFAIRS (SHRI MALLIKARJUN): (a) Yes. The earnings in foreign exchange during 1979-80 and 1980-81 were Rs. 4,72,424 and Rs. 4,85,335 respectively.

(b) to (d). The earnings from sale of Indrail Passes to foreign tourists during 1979-80 and 1980-81 9,14,454 and 12,11,554 in U.S. Dollars respectively. Figures of earnings from internal tourists are not separately maintained.

A pilot project called "Palace on Wheels", a rail package, is proposed to be launched for development of tourism in Rajasthan in coordination with Rajasthan Government.
