Two suggestions made in the Press Statement pertain to improvement of bridges on the section and doubling of the entire section. Attention to bridges is a continuous process. Doubling of track is taken up where justified and to the extent, resources permit.

THE DEPUTY MINISTER IN THE MINISTRIES OF RAILWAYS, AND FDUCATION AND SOCIAL WELFARE AND DEPARTMENT OF PARLIAMENTARY AFFAIRS (SHRI MALLIKARJUN): (a) Yes, Inquiries into unlawful possession of released rails belonging to the Railways by M/s New Steel Fabricator Union, Manaparai have been made.

(b) On 23-7-1981, 15 welded Panel Rails which had been replaced and were kep alongwith the side of the track between Thirumaiyam and Chettinad Stations were found missing. During inquiries, on an information, the house of one Shii Muthaliff at Dindigul Road, Manaparati, was searched on 27-7-81 and 48 rail pieces if varying lengt from 2.4 to 3.5 to metres, valued at about Rs. 15,000/- was recovered. Shri Muthaliff was arrested. A case under Section 3 RP (UP) Act was registered at the RPF Post, Dindigul, and further inquiries were taken up. While the inquiry of the case was in progress, Shri Mohd. Yusuf, Shri Haji Yusuf, Shri Abdul Aziz and Shri Naswridin obtained anticipatory bail from courts, hence they were released. The lorry which was used for transporting the stolen railway property was seized and the driver and cleaner of the lorry were arrested. The case is still under inquiry.
