13-2-1981 and sank in the centre of the Indira Dock channel. Initial efforts made by Indian Navy to salvage the vessel failed. Owner of the vessel has disowned responsibility to remove the wreck. Negotiations with the Indian Navy are underway to blast the wreck as it is found that wreck cannot be floated

Lash Barge 'DM 172':

The Lash Barge anchored close to cross island sank on 11-8-1981 due to squally weather. Agents M/s Transocean Shipping Agency Private Limited in consultation with owner's representative, are negotiating with salvage firms to remove the wreck.

Pandey Committee Findings of JEE

2017. SHRI MOOL CHAND DAGA: Will the Minister of EDUCATION AND SOCIAL WELFARE be pleased to state:

- (a) whether Board of Governors IIT, Delhi, has rejected the N. S. Pandey committee findings on JEE 1979 scandal which held four faculty members guilty of serious malpractices;
 - (b) if so, the reasons therefor;
- (c) whether the punishments awarded to guilty faculty members are trivial and not commensurate with the seriousness of charges established against them;

(e) whether some of these faculty members have gone abroad during the pendency of punishments so that these become ineffective;

(f) if so, how their visits abroad were cleared;

(g) whether a senior Professor of IIT, Delhi, invigilated at a JEE centre where his own nephew was a candidate; and

(h) if so, what action has been taken against him?

THE DEPUTY MINISTER IN THE MINISTRIES OF RAILWAYS AND EDUCATION AND SOCIAL WELFARE AND DEPARTMENT OF PARLIAMENTARY AFFAIRS (SHRI MALLIKARJUN): (a) to (f). One of the accused in the case has appealed to the High Court against the penalties imposed upon him by the Board of Governors of IIT, Delhi. The whole issue is, therefore, subjudice.

(g) Yes, Sir. However, the invigilation duties were assigned to the Professor in a room other than that where his nephew was sitting.

(h) In view of the clarification given in (g) above and since there is no evidence to link the Professor's invigilation with anything undesirable, the question of taking any action against him does not arise.

National Moral Education Conference

2018. SHRI MOOL CHAND DAGA: Will the Minister of EDUCATION AND SOCIAL WELFARE be pleased to state:

a) the resolutions adopted in the first National Moral Education Conference held at Lucknow on the 11th, 12th and 13th July, 1981 and Government's reaction thereto and whether a copy of each of them will be laid on the Table; and

(b) whether Government have taken a decision to impart moral education and implement the above resolutions and if so, the broad outlines thereof and how this is proposed to be included in the education system so as to ensure that students become duty conscious citizens of the country?

THE DEPUTY MINISTER IN THE MINISTRIES OF RAILWAYS, EDUCATION AND SOCIAL WELFARE AND DEPARTMENT OF PARLIAMENTARY AFFAIRS (SHRI MALLIKARJUN):
(a) According to information available, the City Montessori School of Lucknow organised a National Moral Education Conference at Lucknow from 11th to 13th July, 1981. A copy of the resolutions adopted in the said Conference, received from the organisers, is attached.

(b) The Government is of the view that the building up of character of students should be one of the major aims or education. Cultivation of moral and social values by pupils should be encouraged through all curricular extra-curricular activities, education system must produce young men and women of character should be committed to national service and development. Some basic issues concerned with the programme of moral education were discussed in a high level Seminar on Moral Education organized by NCERT in May, 1981. Among other things the Seminar also recommended that provision should be made for moral education in all the schools of the country and that NCERT should go ahead with developing curriculum and instructional materials and teachers orientation for this purpose. The recommendations of the Seminar have been communicated to all States/Union Territor'es for consideration and implementation.
