and 7th joint meetings held in January, 1978, October, 1978 and June, 1981 respectively the Central Council of Health had adopted resolutions wherein the Council recommended that the States should establish well organised analytical laboratories capable of testing samples of all categories of drugs and set up legal-cumintelligence cells suitably equipped for tackling the problems of spurious drugs.

- (b) Yes, some of the States and Union Territories have no full-time Drug Controllers with adequate qualifications.
- (c) The Ministry of Health and Family Welfare had forwarded copies of the Resolutions to all the State Governments and Union Territories requesting them to implement the various recommendations of the Central Council of Health and to furnish implementation reports. The States of Maharashtra, Tamil Nadu, Gujarat, Kerala and Karnataka have facilities for testing of all categories of drugs, 12 States and Union Territories have facilities for testing only non-biological products, while seven States and Union Territories do not have facilities for testing of drugs. The State Governments of Gujarat, Kerala, Madhya Pradesh, Rajasthan, Maharashtra, Karnataka, Uttar Pradesh, West Bengal and Union Territory of Delhi have established legal-cumintelligence wings for tackling the problems of spurious drugs. other States and Union Territories have so far no such machinery.

Widening of National Highway No. 15

2048 SHRI VIRDHI CHANDER JAIN: Will the Minister of SHIP-PING AND TRANSPORT be pleased to state:

(a) whether Government propose to undertake the widening work of National Highway No. 15 to two lane width especially in desert area of Barmer and Jaiselmer Districts of Rajasthan where the traffic has increased to a large extent, in the Sixth-Five Year Plan; and

(b) if not, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF SHIPPING AND TRANSPORT (SHRI BUTA SINGH):
(a) and (b). No, Sir. Present traffic on this road between Bikaner to Rajasthan/Gujarat Border does not warrant double laning at the moment.

Railway lines sanctioned for construction

2049. PROF. NARAIN CHAND PARASHAR: Will the Minister of RAILWAYS be pleased to state:

- (a) the names of railway lines, which have been sanctioned for construction, Zone-wise alongwith the kilometrage, estimated cost and the likely period of construction in each case, during the last 3 years including the current financial year; and
- (b) if the construction work has not commenced so far, the likely date by which it would begin and the reasons for delay alongwith the amount earmarked in the Budget/Supplementary Budget during the current year and also the allocation for each line in 6th Five Year Plan in each case?

THE DEPUTY MINISTER IN THE MINISTRIES OF RAILWAYS AND EDUCATION AND SOCIAL WELFARE AND DEPARTMENT OF PARLIAMENTARY AFFAIRS (SHRI MALLIKARJUN): (a) and (b). A statement is laid on the Table of the House [Placed in Library. See No. LT-3014/81].

Opening of New Central Schools

2050. PROF. NARAIN CHAND PARASHAR:

SHRI SAJJAN KUMAR:

Will the Minister of EDUCATION AND SOCIAL WELFARE be pleased to state:

(a) whether any new central schools are planned to be opened in the year 1982-83;

- (b) if so, the names of the places with States in which the schools have been sanctioned;
- (c) whether any proposals/requests for opening new central Schools are pending with Government for considerations; and
- (d) if so, the names of the places for which the proposals are under consideration and the likely date by which the decision on them would be taken?

THE DEPUTY MINISTER IN THE MINISTRIES OF RAILWAYS AND EDUCATION AND SOCIAL WEL-FARE AND DEPARTMENT OF PAR-(SHRI LIAMENTARY AFFAIRS MALLIKARJUN): (a) Yes, Sir.

(b) The Kendriya Vidyalaya Sangathan have been authorised to open Kendriya Vidyalayas (Central Schools) in the country during the year 1982-83. Besides, some Kendriya Vidyalayas are also likely to be opened at places where institutions of higher learning/public undertakings are located.

The locations for Kendriya Vidyalayas to be opened during the next year are to be decided by the Sangathan at the time of commencement of the next academic session. It is not possible to indicate at this stage the names of such places.

(c) and (d). Proposals for opening new Kendriya Vidyalayas are considered by the Kendriya Vidyalaya Sangathan when received from an appropriate sponsoring authority in the prescribed manner. Opening schools is a continuous process. schools are opened in a phased manner, at places where there is demand and where requisite physical facilities in the form of land and buildings etc. are available. As stated in reply to part (b) above, it is not possible to give precise time limits.

Report of the Expert Committee on Medical Education in the country

2051. SHRI B. V. DESAI: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

- (a) whether it is a fact that Centre had appointed an Expert Committee to suggest proposals to give uniformity to medical education in the country;
- (b) if so, whether the Medical Education Review Committee which was set up earlier under the Chairmanship of Shantilal Mehta had submitted its report to the Government;
- (c) if so, whether it is also a fact that terms and reference of the Committee also included the medical man power planning in the health care of the country; and
- (d) when the reports of these committees are likely to be received and examined by Government.

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMI-LY WELFARE (SHRI NIHAR RAN-JAN LASKAR): (a) The Government have appointed a Medical Education Review Committee to review the present medical education system and make recommendations in regard to reform in the context of the national commitment to attain the goal of 'Health for All by the year 2000 AD'.

- (b) The Review Committee for the All India Institute of Medical Sciences, Delhi (including Dr. R. P. Centre for Opthalmic Sciences) and the Post Graduate Institute of Medical Education and Research, Chandigarh, chaired by Dr. Shantilal J. Mehta, has already submitted its report to the Government
- (c) One of the term of reference of the Medical Education Review Committee is to evolve realistic projections of medical manpower requirements during the Sixth Five Year Plan and beyond.
