THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI NIHAR RANJAN LASKAR): (a) to (c). The Review Committee appointed to review the functioning of both the All India Institute of Medical Sciences, New Delhi and the Post-graduate Institute of Medical Education and Research, has submitted its report to the Government. The Government have set-up an Empowered Committee to examine the report of the Review Committee.

Cancun Summit

3140. SHRI CHITTA BASU: Will the Minister of EXTERNAL AFFAIRS be pleased to state:

- (a) whether the Government have since taken any initiative for the follow-up measures of the Cancun Summit's decisions; and
- . (b) if so, the details thereof?

THE MINISTER OF EXTERNAL AFFAIRS (SHRI P. V. NARASIMHA RAO): (a) and (b). The Cancun Meeting was not a universal but a restricted forum in which only 22 countries participated. It was specified in advance that no negotiations or decisions would be undertaken on any global issues at the meeting. The question, therefore, of any follow-up measures on decisions as such does not arise.

However, the summing up by the Co-Chairman indicate consensus on a number of important matters such as, food security and agricultural development; commodities, trade and industrialisation; energy and monetary and financial issues, which need to be taken up in the appropriate fora as

well as on the desirability of Global Negotiations on International Economic Cooperation and Development. India will work energetically for appropriate follow-up action on the above understandings.

Neelkanth Group Temples, District Alwar, Rajasthan

3141. SHRI DAULAT RAM SARAN: Will the Minister of EDUCATION AND SOCIAL WELFARE be pleased to state:

- (a) since when the protection of the Neelkanth Group of Temples, village Garh, District Alwar in Rajasthan has been taken over by the Archaeological Survey of India;

- (c) Facilities like liveries, shoes and torches to the watch and ward staff, as admissible under the existing rules, are provided.
