THE MINISTER OF STATE IN THE MINISTRY OF HEALTH & FAMILY WELFARE (SHRI NIHAR RANJAN LASKAR): (a) The posts of Room Assistants in the pay scale of Rs. 260-400 in the Maulana Medical College and various other medical institutions under the Delhi Administration, have been together for the purpose of promotion to the post of Photographer in the scale of Rs. 425-700. The post Photographer in the scale of Rs. 550-900 in the Maulana Medical College and the Lok Nayak Jayaprakash Narayan Hospital Delhi, have been grouped for the purpose of promotion to the post of Photo Supervisor in the scale of Rs. **650-1200**.

(b) Action is in hand to finalize the inter-se-seniority lists of Dark Room Assistants and Senior Photographers.

... Canadian Restrictions on Indians

3147. SHRI BHIKU RAM JAIN: Will the Minister $o_{\mathbf{f}}$ EXTERNAL AFFAIRS be pleased to state.

- (a) whether it is true that under the recent immigration restrictions imposed by the Canadian Government, visitors from India will be no longer be admitted into Canada without visas;
- (b) if so, is India the only Commonwealth country in whose case such restrictions have been imposed; and
- (c) if, so the remedial measures taken/or proposed to be taken by the Government?

MINISTER OF EXTERNAL THE AFFAIRS (SHRI P V. NARASIMHA RAO): (a) Yes, Sir.

- (b) No. Sir. Visas to enter Canada are also required by nationals of Nigeria and Ghana.
- (c) The Government of India has conveyed to the Canadian authorities our view that the introduction of the visitors visa system should not imlegitimate pede travel between national_s \mathbf{of} two Commonwealth countries. The Government of Canada have stated that they would this in mind in administering the visa system They have also indicated that the visa system will be kept under constant review.

THE DEPUTY MINISTER IN THE MINISTRIES OF RAILWAYS EDUCATION AND SOCIAL WEL-FARE AND IN THE DEPARTMENT OF PARLIAMENTARY **AFFAIRS** (SHRI MALLIKARJUN): (a) Yes, Sir. The Delhi Urban Art Commission have however included in the heading "Projects for Asian Games. 1982" construction Of hetels, fly-overs, widening of roads, etc., which are not Asiad projects but which yorm part of the normal development programme of the concerned authorities. The construction of these projects has been advanced so that the benefit is available at the time of Asian Games, 1982.

- (b) Besides making a number of useful suggestions about construction/renovation of some of the stadia, the Commission made the following major obervations:
 - (i) Some of the major of developments were being proposed without adequate study.
 - (ii) The construction of fly-overs and some other structures involved the felling of large number of trees.
 - (iii) The proposed hotel within a residential area was not acceptable.
 - (iv) The proposed hotel near Jantar Mantar would create a very tall structure in the vicinity of manuments which might not be a desirable proposition

(v) The scheme of the Asian Games. Village Complex was interesting.

The proposal submitted by the concerned authorities were considered by the Commission and were finally approved after the suggestions made by them had been incorporated. regards the hotel within a residential area, this is not included in the hotels approved for providing facilities for As regards felling of Asian Games. trees, the concerned agencies replanting the trees to the maximum extent possible and are also planting a large number of new trees which are many times more in number than the trees to be felled.
