## Indo-Bahrain Agreement for Kudremukh ore

Will the Minister of STEEL AND MINES be pleased to state:

- (a) whether India and Bahrain have reached complete understanding on the technical specifications of Kudremukh Ore to be supplied for the four million tonne pelletisation plant being built in the Gulf island; and
  - (b) if so, the details thereof?

THE MINISTER OF COMMERCE AND STEEL AND MINES (SHRI PRANAB MUKHERJEE): (a): Yes, Sir.

(b) As a result of the visit of an Indian delegation to Bahrain in October 1981, a Letter of Intent has been issued by the Arab Iron and Steel Company, Bahrain (AISC) to the Kudremukh Iron Ore Company Limited agreeing to buy 1.5 MT of concentrate per year beginning from mid. 1984, for a period of five years. The prices for the concentrate will have to be negotiated each year, based on international prices of similar material from other sources.

3329. SHRI P. RAJAGOPAL. NAIDU: Will the Minister of FINANCE be pleased to state:

- (a) whether it is a fact that Government have withdrawn their request for a loan of dollar 260 million from I.D.A., to set up cement factories; and
  - (b) if so, the reasons therefor?

THE MINISTER OF FINANCE (SHRI R. VENKATARAMAN): (a) and (b). A project of the Cement Corporation of India was under appraisal of the World Bank for a possible loan of \$230 million. However, as the financing of this project by the Bank was likely to take time and as this would have adversely affected the schedule for commissioning additional capacity in this vital sector, it was decided to proceed with the project with our own resources.
