mind such companies as were conducting prize chits, savings and benefit schemes. During the period from 1978 to October, 1981 the Reserve Bank recomplaints against such ceived 171 companies containing allegations of misapproprition of funds, non-payment of prizes/deposits etc.

- (c) In terms of the provisions of the Prize Chits and Money Circulation Schemes (Banning) Act, 1978 which has come into force with effect from 12-12-1978 the promotion/conduct of prize chits/benefit schemes has been banned. The provisions of this Act are to be administered by the State Governments who are empowered to take appropriate action in the matter.
- (d) According to the Reserve Bank's record, during the period from 1978 to October, 1981, 17 complaints were received against prize chits/benefit companies in Gujarat viz., Gujarat Savings Unit Pvt., Ltd., Santosh benefit Pvt. Ltd., Divya Vasundhara Financiers Ltd., Prasant Benefit and Trading Company Pvt. Ltd., and Kavita Benefit Pvt. Ltd.

Reports received by Governshow that only insignificant quantities of opium have figured international seizures, Besides, quantities of opium seized while being attempted to be smuggled out of the country have also been small compared to the total production of opium in the country.
