(b) Under the Low Income Group Housing Scheme envisaged by the Ministry of Works, Housing and Supply these societies are required to ecure loans direct from the State State Governments concerned Governments, at the request of Ministry of Railways, have ensured that these societies will be given equal benefits, financial and otherwise, like other Housing Societies which been set up under State Governments

## Jaipur Post Office (Orissa)

339. Shri B. C. Mullick: Will the Minister of Transport and Communications be pleased to state.

- (a) whether Government are aware of the fact that due to delay in constructing a building of its own, the Post Office at Jaipur town, Orissa continues to be housed in the local Town Hall causing inconvenience to the public,
- (b) if so, what steps are being taken for the speedy completion of the work and the target fixed for it, and
- (c) the annual amount of expenditure incurred on account of rent?

The Minister of State in the Ministry of Transport and Communications (Shri Raj Bahadur): (a) Jaipur Head Post Office has been temporarily located in the Town Hall premises pending construction of departmental building for the office No complaint has been received about inconvenience caused to public due to its location in the Town Hall

(b) Administrative approval and expenditure sanction to the construction of the building was issued in May, 1954, but the work could not be executed as the CPWD authorities were unable to fix the agency for its execution. Fresh tenders invited by them were expected to be opened on 25th July, 1957

If Jamuna goes on rising, what is the meaning of adjourning the House? I can only say to the hon Minister, because every day, every morning we find that the danger point is being reached and so on, any statement on the floor of the House might be welcome. The hon Prime Minister

The Prime Minister and Minister of External Affairs (Shri Jawaharlal Nehru): It is obvious, as you yourself have been pleased to indicate, that this is not a matter for an adjournment motion

This is an annual occurrence and a normal occurrence Unfortunately sometimes it creates difficulties which cannot immediately be dealt with because now that Delhi is spreading out, people start living in the lowlving areas and they are being removed Anyhow it will interest the House to know that at 11-30 am this morning the water leve' on the Jamuna was 6714 ft, that is it has gone down a little The danger point is 672 ft above sea level The water started receding at 12 noon, esterday and is fast continuing to recede It has not. therefore, been necessary to carry out any relief measures

This, I may point out, is in answer to future questions also
