The Deputy Minister of Defence (Shri Raghuramaish): (a) There is no shortage of suitable officers for promotion in place of the merely retired officers. But in addition to the vacancies caused by the retirement of officers there are many other vacancies because of the overall shortage of officers in the Armed Forces. Reemployment of retired/released officers has become necessary on this account.
