cases have been challaned and punishment meted out during 1956 and 1957 so far; and

(b) the names of the States where illicit traffic in opium is carried on mostly and the steps Government proposed to take to prevent its smuggling?

The Minister of Finance (Shri T. T. Krishnamachari): (a) A statement is placed on the Table of the House, [See Appendix II, annexure No. 34.]

(b) The States where illicit traffic in opium is carried on mostly are the opium growing States of Madhya Pradesh, Rajasthan and Uttar Pradesh and the State of Punjab.

Various steps including strengthening of preventive staff in the opium growing areas as well as at Customs borders are being taken to prevent such smuggling.

377. Shri N. R. Munisamy: Willthe Minister of Finance be pleased to state the total amount of income tax collected from the Hindu Undivided Families in the year 1956-57?

The Minister of Finance (Sari T. T. Krishnamachari): Figures of collections of Income-tax are not tabulated according to the status of the assessees. However, the amount of tax demanded from Hindu Undivided Families in 1955-56 is Rs. 12,02,98,607[-. The figures for 1956-57 are not yet available. They will be laid on the table of the House as soon as the figures are ready.
