Power Situation in Rajasthan

Will the Minister of ENERGY be pleased to state:

- (a) whether in view of the serious power situation in Rajasthan, Government have any plans for setting up super thermal power projects in the Central sector;
 - (b) if so, the details thereof; and
- (c) the programme of their completion?

THE MINISTER OF STATE IN THE MINISTRY OF ENERGY (SHRI VIKRAM MAHAJAN): (a) to (c). Rajasthan has an allocation of 53 MW from the first stage of the 600 MW installed capacity and an allocation of 300 MW from the final installed capacity of 2000 MW of the Super Thermal Power Station being set up by the National Thermal Power Corporation at Singrauli in Uttar Pradesh. Work is progressing on the project on schedule and the first unit of 200 MW capacity is expected to be commissioned by February, 1982.
