- (a) whether Japanese Government have extended a loan to India for the construction of a urea plant;
- (b) whether it is a fact that this plant would be using natural gas resources of developed off Bombay; and
 - (c) if so, the details of this project?

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM, CHEMICALS AND FERTILIZERS (SHRI DALBIR SINGH): (a) to (c). The Government of Japan have extended a loan of 20 billion Yen for the Thal Fertilizer Project, Part of this assistance is to be utilised for the purchase of some equipment for the urea plant. This project would be using the associated/natural gas from the Bombay High/Bassein fields. has an annual capacity of 6.83 lakh tonnes of Nitrogen.

Silent Valley Project

3774. SHRI E. K. IMBICHIBAVA: Will the Minister of ENERGY be pleased to state:

- (a) what is the position of Silent. Valley Project which was designed for an annual generation of 522 million units of electrical energy and irrigation of 100,000 hectares of land in Palghat and Malappuram districts. sanctioned by the Planning Commission in 1973 and left to an expert committee for submitting a report within three months to look into the ecological angle of the project in 1980;
- (b) has the expert committee submitted its report; and
- (c) if so, what are the findings of the committee?

THE MINISTER OF STATE IN THE MINISTRY OF ENERGY (SHRI VIK-RAM MAHAJAN): (a) to (c) Implementation of the Silent Project has been held up on account of serious reservations expressed from environmental angle. The matter is under examination of the Department of Environment. The Joint Centre-State Committee on the Silent Valley Hydro-Power Project set up for this purpose is expected to submit its report by March, 1982. The question of implementation of Silent Hydro-electric Project would be reviewed after the recommendations of this Committee are received
