- (b) is it also a fact that the Department have not been able to do much in the matter due to shortage of stores;
- (c) is it a fact that the subscribers in the region are finding great difficulty due to the inadequate performance of the Department; and
- (d) if so, what action Government contemplate to improve the position?

THE DEPUTY MINISTER IN THE MINISTRY OF COMMUNICATIONS (SHRI VIJAY N. PATIL); (a) Yes, Sir.

- (b) New S.A.X., C.B. Exchanges, and P.O.Os. are being opened depending upon the availability of stores.
- (c) Difficulty to subscribers is at par in all areas. Dut to shortage of raw material and exchange equipment to some extent all sanctioned works could not be undertaken.
- (d) The position regarding supplies of stores during this year has improved and it is likely to improve further due to availability of raw material.

Cross-Bar Exchange System at Poonamallee in Tamil Nadu

3888. SHRI ERA ANBARASU: Will the Miniser of COMMUNICATIONS be pleased to state:

- (a) whether Government are aware of the fact that Telephone Exchange at Poonamallee (Chingleput district) in Tamil Nadu is out of order almost every day;
- (b) whether Government propose taking proper steps to instal modern equipment to tone up the proper functioning of the Telephone Exchange at Poonamallee; and
- (c) whether Government also propose to consider the setting up of a cross-bar exchange system at Poonsmallee?

THE DEPUTY MINISTER IN THE MINISTRY OF COMMUNICATIONS (SHRI VIJAY N. PATIL): (a) No, Sir. The Poonamallee exchange was never totally out of order.

- (b) The exchange is a MAX-II type 400 lines Strowger Exchange. It has been only recently shifted to a new departmental building. There are no plan, to replace this exchange. The exchange is functioning satisfactorily.
- (c) There is no proposal for a cross-bar exchange at Poonamallee.
