

Posts of Hindi Officers advertised by UPSC

4053. SHRI JITENDRA PRASAD: Will the Minister of HOME AFFAIRS be pleased to state:

(a) the number of posts of Hindi Officers in the scale of Rs. 1100—1600 in various Ministries/Departments advertised by the UPSC during the last three years; and

(b) the number of applications fulfilling the essential qualifications received and the reasons for not calling all the applicants for test/interview?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS AND IN THE DEPARTMENT OF PARLIAMENTARY AFFAIRS (SHRI P. VENKATASUBBALAH):

(a) According to the information furnished by the UPSC, there was only one advertisement issued on 7-11-1981 by the UPSC in the last three years, for 15 posts of Hindi Officers in the Ministry of Railways.

(b) As the closing date for receipt of applications from candidates from abroad, Andaman & Nicobar Islands, Lakshdweep, North Eastern region etc., that is 21-12-1981, is not yet over, this question does not arise at this stage.

Housing Facilities to Retired Military Personnel

(a) whether there is any proposal before Government to give directives to State Governments for giving Housing facilities to retired military persons; and

(b) if so, what are they?

THE MINISTER OF STATE IN THE MINISTRY OF DEFENCE (SHRI SHIVRAJ V. PATIL): (a) and (b). In the interest of the welfare of the serving and retired military personnel, the State Govern-

ments/Union Territories Administrations have been requested to consider reservation of houses and plots for the serving/retired service personnel. They have also been requested to favourably consider the grant of land at concessional rates to Co-operative Housing Societies of serving/retired military personnel.

(ख) यदि हां, तो क्या आग लगने के कारणों की जांच करने के आदेश दे दिए गए हैं; और

(ग) यदि हां, तो इस बारे में रिपोर्ट कब तक भिज जायेगी ?

रक्षा मंत्रालय में राज्य मंत्री (श्री शिव राज वी० पाटिल) : (क) नवम्बर, 1981 में एक सैनिक विमान उड़ान भरने के तुरन्त बाद गिर कर नष्ट हो गया था ।

(ख) दुर्घटना के कारणों की जांच की जा रही है ।

(ग) यह बताना सम्भव नहीं है कि जांच कब तक पूरी होगी ।

बोकारो में धातुमल (स्लेम) सिमेंट फ़ैक्ट्री का लगाया जाना

(क) क्या बोकारो इस्पात संयंत्र से निकले धातुमल पर आधारित सिमेंट

फैक्ट्री लगाने के बारे में निर्णय ले लिया गया है ; और

(ख) यदि हां, तो यह फैक्ट्री कब तक लगाई जायेगी और क्या यह भवनाथपुर (जिला पलामू) में लगाई जायेगी या बोकारों में ?

उद्योग मंत्रालय में राज्य मंत्री (श्री धरण जीत चानना) : (क) तथा (ख). बोकारों स्लैग पर आधारित उत्तर प्रदेश राज्य सीमेंट निगम के दो सीमेंट संयंत्रों और मै० कल्याणपुर लाइम एण्ड सीमेंट वर्क्स की स्थापना की जा चुकी है। एक अन्य आवेदन जिसमें जदुनाथपुर (जिला रोहतासपुर) में क्लिंकराइजेशन और भवनाथपुर (जिला पालामऊ) में पिसाई और पैकिंग करने की परिकल्पना की गई है पर कार्यवाई की जा रही है। इस स्तर पर यह बता पाना कठिन है कि संयंत्र किस समय तक स्थापित हो जाएगा।

Setting up of Chemical Micro-electronic Factories in Tamil Nadu Organisation

THE MINISTER OF STATE IN THE DEPARTMENTS OF SCIENCE AND TECHNOLOGY, ELECTRONICS AND ENVIRONMENT (SHRI C. P. N. SINGH): (a) No, Sir.

Account Facilities to Pensioners of Ordnance Factories

4058. SHRI MOHAMMED ISMAIL: Will the Minister of DEFENCE be pleased to state:

(a) whether Government have received a representation dated 12 May, 1981 from the Ishapur Ordnance Factory's Mazdoor Union, Goalpara, West Bengal regarding the account facilities to pensioners of Ordnance factories;

(b) if so, details thereof; and

(c) action taken by Government to extend account facilities to pensioners of Ordnance factories?

THE MINISTER OF STATE IN THE MINISTRY OF DEFENCE (SHRI SHIVRAJ V. PATIL): (a) Yes, Sir.

(b) The Union represented that the branches of Allahabad Bank and State Bank of India at Ishapur were refusing to provide facilities to the local Defence employees on the verge of retirement to open pension accounts.

(c) The matter was taken up with the respective Branch Managers who have refuted the allegation and have confirmed that the facilities have been provided.
