THE MINISTER OF STATE IN THE MINISTRIES OF RAILWAYS AND EDUCATION AND SOCIAL FARE AND IN THE DEPARTMENT AFFAIRS PARLIAMENTARY (SHRI MALLIKARJUN): (a) to (c). A statement is attached.

The Indian Railway Conference Association, an autonomous body, has been assigned the following functions connected with the Railways:

- 1, to frame rules for the management of traffic interchanged between Railways;
 - 2. to act as a Board of Conciliation;
- 3. to maintain records of wagon interchanged and hire charges, Broad Gauge and Metre Gauge separately between Indian Railways, as well as between Indian Railways and ways in Pakistan and Bangladesh, as directed by the Railway Board;
- 4. to conduct the Neutral Control of examination of Broad and Metre Gauge wagons at nominated inter_change junctions, yards, workshops and sick
- 5. to render advice on other subjects relating to Railways which may be referred to it by member Railways or Railway Board; and
- 6. to carry out such other functions as may, from time to time, be assigned to it.

The budget grants for I.R.C.A. are charged to the revenue accounts the Railways who are party to the Indian Railway Conference Association.

There is no difference in scales of pay and allowances paid to I.R.C.A. Staff and to staff working on Zonal Railways. The staff of I.R.C.A. have generally been given the same facilities and amenities as given to the Railway employees except facility of house building advance and new Group Insurance Scheme applicable to Central Government employees on the ground that I.R.C.A. staff are not Central Government staff.

There is no proposal to alter the present status of I.R.C.A.

Property Left Behind by Indians in Kampuchea

4239. SHRI C. D. PATEL: SHRI AHMED MOHAMMED PATEL.

Minister of EXTERNAL Will the AFFAIRS be pleased to state:

- (a) whether it is a fact that many Indians left behind their shops goods, properties, Cash bank balances and all their assets, because they had to leave the Kampuchea when Prince Sihanouk was over-thrown by Khmer Rouge forces; and
- (b) if so details of action taken on this score?

THE MINISTER OF EXTERNAL AFFAIRS (SHRI P. V. NARASIMHA RAO): (a) and (b). It is true that most foreigners, including Indian nationals, had to leave behind their assets following the overthrow of the then gov. ernment of Cambodia in April, 1975. The Government of India have received some representations some of these Indian nationals seeking compensation in respect of property left behind by them. The matter could not be pursued earlier because there were no diplomatic relations between India and the regime that had come to power in Kampuchea. But India has recognised the Heng Samrin Government last year and an Embassy was also opened there earlier this year. The matter is therefore being pursued further,
