THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS EDUCATION AND SOCIAL WELFARE THE DEPARTMENT OF AND IN PARLIAMENTARY AFFAIRS (SHRI MALLIKARJUN): (a) and (b). Yes. Apart from stoppage of 230 Banaglore Express at Guntakal, 95 96 Marwar Mail stops at Jodhpur more than 3 hours for operational reasons.

230 Hubli\_Bangalore Express stops at Guntakal Junction for 3 hours (Arr. 23.15; Dep. 2.15) as it has maintain important connections Guntakal with 29 Hyderabad-Tirupati Express, 13 Bombay-Madras Express and 97/98 Tirupati-Secunderabad Expresses where slip coaches for Secunderabad and Tirupati are transferred.

- (a) whether it is a fact that the Specialists of C.G.H.S. for various diseases had not so far started visiting the CGHS Allopathic and Ayurvedic Dispensaries on Mehrauli Badarpur Road (Pushp Vihar) New Delhi;
- (b) if so, what are the reasons that the CGHS beneficiaries residing Pushp Vihar are not getting this facility at nearer distance as in the case of other colonies:
- (c) whether Government propose to give this facility to the CGHS beneficiaries residing in Pushp Vihar in the near future; if so, by when; and

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAM-ILY WELFARE (SHRI NIHAR RAN-LASKAR): (a) to (d). Specialists of CGHS visit a number of selected dispensaries, according to the schedule. The beneficiaries of other surrounding dispensaries avail of the services of specialists by visiting the nodal dispensary on the appointed day. Similarly, the beneficiaries of Mehrauli Badarpur Road Dispensary are attached to Malviya Nagar this purpose to avail of the Medical Specialists Services who goes according to schedule. As regards specialists in other disciplines. beneficiaries have to attend Safdarjang Hospital where these services are provided. For consultation with Ayurvedic Specialist they can avail of these services at Ayurvedic Hospital, Lodi Road. In view of their arrangements and administrative reasons, it is not considered possible to provide Specialists Services at each dispensary.
