# Select grade to Teachers in Goa

PROF. MADHU DANDA-4338. VATE: Will the Minister of EDUCA-TION AND SOCIAL WELFARE pleased to state:

- (a) whether the Government of Goa has taken any steps in settling the issue connected with the selection grade to the teachers in Goa in the light of the advice given by the Centre: and
- (b) if so, the issue when likely to be settled?

THE DEPUTY MINISTER IN THE MINISTRIES OF RAILWAYS AND EDUCATION AND SOCIAL FARE AND IN THE DEPARTMENT PARLIAMENTARY AFFAIRS (SHRI MALLIKARJUN); (a) and (b) Teachers in the Government Schools in Goa have already been awarded the Selection Grade. It has however, not been possible to grant selection grade to the teachers in aided Schools in Goa, Daman and Diu so far because one of their representative organisations is opposing the same. They are demanding the modification of the existing selection grade rules. They want that selection grade should be given to the teachers who have rendered a minimum number of years of service. The whole matter is under consideration at present and it is not possible to precisely indicate the time limit by when the matter is likely to be settled.

- (c) what will be total cost for its construction?

THE DEPUTY MINISTER IN THE MINISTRIES OF RAILWAYS AND EDUCATION AND SOCIAL FARE AND IN THE DEPARTMENT PARLIAMENTARY AFFAIRS OF MALLIKARJUN): (a) (SHRI works connected with the Ring Railway are well underway and progressing satisfactorily. Doubling of track is nearing completion and electrification and signalling works which have been taken in hand are also going on as per schedule.

- (b) The Ring Railway Project is likely to be completed by June 1982 and start operation before the commencement of Asian Games.

## Autonomous Status to B.I.T. Mesra (Ranchi)

- (d) if so, what were the conditions decided upon and other details thereof and what steps the U.G.C. has taken to ensure that these conditions have been fulfilled?

THE DEPUTY MINISTER IN THE MINISTRIES OF RAILWAYS AND EDUCATION AND SOCIAL WELFARE AND IN THE DEPARTMENT OF PARLIAMENTARY AFFAIRS (SHRI MALLIKARJUN): (a) Yes, Sir.

- (b) The objection of the U.G.C. was against the disaffliation of the college from the Ranchi University.
- (c) A meeting was held in October,

(d) The U.G.C. suggested that the affiliated status of the BIT, Messers. Ranchi may be restored and autonomous status may be given by amending the Acts and Statutes of the Ranchi University. The State Government agreed to the suggestion and the position was rectified accordingly by an Ordinance of the State Government dated 5th May, 1974.
