THE MINISTER OF SHIPPING AND TRANSPORT (SHRI VEEREN-DRA PATIL): (a) During the year 1981 upto October there were 9 incidents of hijacking of buses by the students.

(c) 39 buses were damaged.

(d) The estimated loss on account of missed trips was Rs. 6118/- and damage to the buses was Rs. 37,398/-.

(b) and (c). Approximately 1100. The Railway population at Singrauli is presently getting medical facilities from Central Coal Field Ltd. Hospital. If need arises, railway doctors from Chopan Health Unit and from Renukoot attend to their medical requirements.
