'A' in oil are administered twice a year to the children of age group of one to five years Gov-India has ernment of launched National Programme for Control of Blindness to provide comprehensive Eye Care Services from peripheral to

Apex level. As a temporary measures, under the Crash Programme, immediate comprehensive Eye Care Services, are provided through mobile units. Screening of School children is one of the activities of the mobile unit. Permanent infrastructure for eye care is being developed in three tier system of general Health Services at peripheral, Intermediate and Central levels.

## Return of castaway Indians

- (a) whether Government's attention has drawn to the news-item under the caption 'Harrowing tale of Indian castaways', as published in the Indian Express dated 12 November, 1981 regarding return of castaway Indians;
- (b) whether six men were ashore from a Timorese fishing boat at Irvine island, an uninhabited island off West Australia's North-west coast on November 6, 1981:

After verifying their national status and after completion of due formalities, necessary arrangements were made for their return to India at Government cost. All the six persons were given travel documents for their return journey. They arrived in India on 18th November, 1981.
