THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI SAWAI SINGH SISODIA): (a) No, Sir.

- (c) Against the authorised strength of 13 IDAS Officers, there is a shortage of one Officer only.

Measures to check Proliferation of Black Money

Losses in HSCL

- 4453. SHRI PALAS BARMAN: Will the Minister of STEEL AND MINES be pleased to state:
- (a) is it a fact that Hindustan Steel-works Construction Ltd. has

been facing marked deterioration in the financial years 1979-80 and 1980-81:

- (b) if so, the reasons for this State of affairs; and
- (c) the steps taken by Government to make it financially viable?

MINISTER THE OF COM-MERCE AND STEEL AND MINES (SHRI PRANAB MUKHERJEE): (a) Yes, Sir. Hindustan Steelworks Construction Limited (HSCL) has suffered substantial losses during 1979-80 and 1980-81.

- (b) The Company has been incurring losses because a number of contracts have turned unprofitable due to increases in costs which could not be neutralised under the terms of the contracts, unremunerative rates and industrial relations problems including constraints in matter of deployment of manpower.
- (c) As the Company is facing a number of problems Government is consideration serious various steps possible in consultation with the management of the Company on a continuing basis like securing more work, improvement in efficiency. review in the terms of contract by clients discussion with wherever possible and finding solutions to the industrial relations problems.

Relief to Families of Employees Dying in Service

4454. SHRI RAJNATH SONKAR SHASTRI: Will the Minister of FINANCE be pleased to state:

(a) whether there is a scheme for providing immediate relief to the families of employees dying while in service in receipt of pay not exceeding Rs. 1200/- p.m. subject to the maximum of Rs. 1000/- or 3 months' pay whichever is less:

- (b) if so, whether this amount is proposed to be increased to Rs. 2500/or 3 month's pay, whichever is less, keeping the steep hike in prices;
- (c) whether it is proposed to convert this advance into a grant to all employees dying while in service or after retirement as a token of love shown by Government towards their employees; and
- (d) how many families received benefits under the Compassionate Fund of India during the last three years and on what grounds; as also the families given immediate relief of Rs. 1000/- during the last 6 months in Finance Ministry?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI SAWAI SINGH SISODIA): (a) to (c) Under a Scheme introduced in 1971 and modified from time to time families of Government servants drawing pay up to Rs. 1200/p.m. who die while in service are eligible for immediate relief in the form of advance limited to three months' pay or Rs. 1000/- whichever is less. There is no proposal to increase the amount of immediate relief or to convert this advance into a grant.

(d) Grants from the Compassionate Fund of India were sanctioned to 243 families during the last 3 years on grounds of indigent circumstances. During the months, immediate relief was sanctioned in one case in the Ministry of Finance (Secretariat).
