THE MINISTER OF COMMUNICATIONS (SHRI BENI PRASAD VARMA): (a) No Sir, the telecommunications services are satisfactory except a few interruptions in the system at Alipurduar in Jalpaiguri District and Harishchandrapur in Maldah District.

- (b) Few complaints were received in the past about telephone services at Alipurduar and Harishchandrapur. The Exchange at Alipurduar has now been replaced by a new digital upgraded in a phased manner. As a consequence, the service at Alipurduar is now substantially improved. There was an interconnection problem between two units of the exchange at Harishchandrapur which has been attended to.
- (c) The following steps are being taken to further improve the service.
 - (i) Routine check of equipments
 - (ii) Immediate rectification of faults.
 - (iii) Ensure sufficient stock of spares and stores
 - (iv) Tight supervision by the officer incharge.
