#### Seizures by Enforcement Directorate

4500. SHRI ATAL BIHARI VAJ-PAYEE :

SHRI SURAJ BHAN :

Will the Minister of FINANCE be pleased to state :

(a) whether the Enforcement Directorate seized in October and November, 1981 a number of documents and cash revealing illegal compensatory payments generally known as "Hawala" deals for transfer of money to Pakistan and some West Asian countries ; and

(b) what are the details thereof including the names of the countries concerned and names and addresses of persons involved in India ?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI SAWAI SINGH SISODIA) : (a) and (b). The Enforcement Directorate searched some premises at Bombay, during October and November, 1981, of persons believed to be indulging in transfer of money between India and Pakistan and as a result thereof, besides documents, foreign exchange amounting to US \$ 923/-, S. A. Riyals 1,67,416/- and Pakistani Rs. 550/- and Indian currency amounting to Rs. 19,09,280/- were seized.

No instance of transfer of money by Hawala transactions from India to West Asian countries has come to the notice of the Directorate during the period October—November, 1981.

The investigations are still in progress. It will not be expedient in the interest of effective investigations to disclose the names and addresses of the persons involved at this stage.

#### Effect of Non-supply of Copper by MMTC on Industry, Particularly Small Units

4501. SHRI KRISHNA KUMAR GOYAL : Will the Minister of COMMERCE be pleased to state :

(a) whether it is a fact that non-supply of copper by Minerals & Metals Trading Corporation had affected the industry, particularly the small units; and

(b) what steps are being proposed by Government to supply the material to the industry ?

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE (SHRI KHURSHED ALAM KHAN) : (a) Minerals & Metals Trading Corporation has been offering

adequate supplies of copper to the industry, including the small units. There was a temporary setback in September/October 1981 when flow of imported cargo was delayed due to congestion at Bombay port. Situation has improved from November and the problems of supplies to the industry have been solved.

(b) MMTC has now arranged adequate stocks in all its godowns to ensure smooth supply of Copper to the industry.

### Fall in Demand for Mica

4502. SHRI JAGDISH TYTLER : Will the Minister of COMMERCE be pleased to state :

(a) the reasons for the fall in demand for mica while the world trade has shown a trade in mica and mica products of around Rs. 200/- crores;

(b) whether it is a fact that export of processed mica has declined due to canalisation ; and

(c) if not, the reasons for the decline and the measures proposed for overcoming this decline ?

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE (SHRI KHURSHEED ALAM KHAN) : (a) to (c). There has been neither a fall in demand nor decline in export of processed mica due to canalisation. This would be evident from the table given below :

The marginal fall in 1980-81 is likely to be more than made up by the increase during 1981-82. The value of exports during the current year upto November has already touched Rs. 18.99 crores as against the corresponding figure of Rs. 13.19 crores during 1980-81. The Mica Trading Corporation, a public sector undertaking, is taking active steps to set up fabrication and manufacturing units for various mica products to improve earnings through export of this commodity.

जबलपुर में "धुआंधार" जल-प्रपात और मेडाघाट के प्रति विदेशी पर्यटकों को आकर्षित करना

4503. श्री सुन्दर शर्मा : क्या पर्यटन और नागर विमानन मंत्री यह बताने की कृपा करेंगे कि जबलपुर स्थित देश के प्रसिद्ध जल-प्रपात "धुआंधार" और सुन्दर स्थान मेडाघाट की ओर विदेशी पर्यटकों को आकर्षित करने के लिए क्या प्रयास किए जा रहे हैं ?

पर्यटन और नागर विमानन मंत्री (श्री अनन्त प्रसाद शर्मा) : धुआंधार जल-प्रपात और मेडाघाट में मार्बल राक्स की ओर विदेशी पर्यटकों को आकर्षित करने के लिए अभी तक कोई विशेष प्रयास नहीं किये गये हैं। तथापि, धुआंधार जल-प्रपात और मेडाघाट की मार्बल राक्स के बारे में केन्द्रीय पर्यटन विभाग द्वारा जबलपुर-कान्हा-अमरकंटक पंचमढ़ी पर प्रकाशित निर्देशिका में सूचना दी गई है, जिसे पर्यटक कार्यालयों के माध्यम से विदेशों में व्यापक रूप से सकुलेट किया जाता है।
