(d) the action Government have taken or propose to take to stop these continuing shortages which entail heavy loss to the national revenue?

The Minister of Food and Agriculture (Shri A. P. Jain): (a) Yes.

(b) Yes, in the audit reports on the Madras Timber Depot for 1954-55 and 1955-56.

(c) During the period from October 1953 to August 1957, the total shortages reported were 368 tons<sup>6</sup> 34 cft. of Sawn timber valued at Rs. 94,603 and 12 tons<sup>6</sup> 10 cft. of logs valued at Rs. 2,284.

(d) A Committee under the Deputy Commissioner, Andaman & Nicobar Islands, has been constituted to look into the question of these shortages and to determine the Forest Department's claims preferred against the Shipping Companies, for short dehvery Pending receipt of the Committee's report, the Chief Commissioner had laid down the following procedure to avoid such losses in future:--

(1) Scantling, should be tied in bundle; before shipment,

(2) Cargo should be tallied both at the time of shipment and at the time of discharge,

(3) Tallying work should be done jointly by the tally clerk of the Indian Coastal Conference Lines, and

(4) Andamars Government Timber Depots should provide clerks for verification at the time of discharging timber

(d) After the introduction of prescribed scales of pay, posts were allocated pro forma in the two pre-1931 scales of pay of Traffic Inspectors, viz, Rs 150-275 and Rs 300-500 for persons who retained the pre-1931 scales of pay The promotion of staff in the lower pre-1931 scale to the higher scale depends on the vacancies available in the higher grade

## Canning and Bottling Unit in Manipur
