# Gram Sewaks

2019. Shri Rameshwar Tantia: Will the Minister of Community Development be pleased to state:

(a) whether it is a fact that in many States Harijans are called Gram Sewak and thus Gram Sewaks of the Community Blocks are treated alike in these States; and

(b) whether it is proposed to allot a proper designation to this category like other category of officers such as S.S.O., B.D.O. and other Extension Officers?

The Minister of Community Development (Shri S. K. Dey): (a) I am not aware of any State where any such misunderstanding exists.

#### Ravalgaon Sugar Pastory

These agreements do not stipulate any price for such purchase and supply as the cane price is fixed by the Government from year to year.

Miraj-Barsi Line

Will the Minister of Kallways be pleased to state:

(a) the steps taken to convert the meter gauge line between Miraj and Barsi Town to broad gauge;

(b) whether any proposals have been received from the public to divert the line to Athavi while converting the line into broad gauge;

(c) if so, whether the proposal has been considered; and

(d) if so, with what result?

The Deputy Minister of Ealiways (Shri Shahnawas Khan): (a) Apparently the Hon'ble Members are referring to the conversion of Narrow Gague line between Miraj and Barsi Engineering and Traffic Surveys for conversion of the line from Miraj to Kurduwadi only are in progress.

(b) Proposals have been received for diversion via Athni and not Athavi

(c) and (d) The Railway Administration have been instructed to comment upon the suggestion from the Engineering and Traffic points of view at the time of preparing the Survey Reports.

#### **Dohad-Dungarpur Line**

2024. Shri Dindod: Will the Minister of Railways be pleased to state:

(a) whether it is a fact that a memorandum was submitted to him by the Dohad-Dungarpur Railway Committee;

(b) whether it is a fact that he had promised in a public meeting to carry out survey of that line; and

(c) if so, whether the proposal has been considered by Government?

The Deputy Minister of Railways (Shri Shahnawax Khan): (a) A representation for the line was received from the Bhil Seva Mandal on behalf of the Jhalod-Banswara Railway Committee.

(b) A survey for the Ratlam-Banswara-Dungarpur line had already been sanctioned. Hence the question of diverting the connection to Dohad did not arise.

(c) The Ratlam-Dungarpur line is not included in 842 miles new lines approved by the Planning Commission for construction during the Second Five Year Plan Period.

### Compensation for Land Acquired for Nangal Dam
