regarding financial participation in the Haldia Petro-chemicals project.

(c) and (d). Several other steps for implementing the project have yet to be finalised. The question of conversion of the letter of intent into an Industrial Licence can be sidered at the appropriate stage.

Release of Postal Stamps in Memory of Sahid Khudiram Basu and Sahid Matangini Hazra

413. SHRI SATYAGOPAL MISRA: Will the Minister of COMMUNICA-TIONS be pleased to state:

- (a) whether there is any proposal under consideration of Government to release postal stamps in the memory of (i) Sahid Khudiram Basu and (ii) Sahid Matangini Hazra;

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICAL TIONS (SHEI KARTIK ORAON): (a) to (c). The general question of issuing commemorative stamps in honour of freedom fighters of the country in a phased manner is being considered by a Sub-Committee of the Philatelic Advisory Committee. Decisions to issue commemorative stamps will be taken after the Committee's recommendations are received.

THE MINISTER OF INFORMA-TION AND BROADCASTING (SHRI VASANT SATHE): (a) and (b). No. final decision has been taken regard ing introduction of colour T.V. transmission in the country. The decisin so far is to provide limited coverage in colour of Asian Games for the use of foreign broadcast organisations.

Drilling of Well in West Bengal by O.N.G.C.

415. SHRI R. P. DAS: Will the Minister of PETROLEUM, CHEMI-CALS AND FERTILIZERS be pleased to state:

- (a) number of wells drilled by the ONGC in West Bengal; and
- (b) what is the result thereof details?

THE MINISTER OF PETROLEUM, CHEMICALS AND FERTILIZERS (SHRI P. C. SETHI): (a) The ONGC have so far drilled six wells in West Bengal, namely, Bodra-1, Bakultala-1, Galsi-2, Galsi-3, Diamond Harbour-1 and Radha-1. During at Abhay well No.1 is over and the well is being tested. In addition, drilling at Jaguli well No. 1 is in progress.

(b) No hydrocarbon indications have been observed in the above wells, However, further testing at Diamond Harbour and Radha wells is proposed to be undertaken.
