## **Barsua** Iron Ore Mines

• 1929. Shri V. C. Shnkla: Will the Minister of Steel, Mines and Fuel be pleased to refer to the reply given to the Starred Question No. 1750 on the 12th September, 1957 and state:

(a) whether Government have since considered the terms and conditions of the proposed agreement with Messrs. Hawitt Robins for the erection and putting into commission of a material handling system at the Barsua iron ore mine for the Rourkela Steel Plant; and

(b) if so, the broad features thereof?

The Minister of Steel, Mines and Fuel (Sardar Swaran Singh): (a) Yes, Sir. The orders for the plant and equipment have been placed on Messrs. Hawitt Robins.

(b) The total cost of the plant and equipment which Messrs. Hawitt Robins will supply is \$4,670,000. Payment has been arranged on deferred terms. The entire equipment is to be shipped to India before the end of 1958, and the erection is to be completed by the end of 1959.

## National Coal Development Corporation, Ranchi

**1930. Shri V. C. Shukla:** Will the Minister of Steel, Mines and Fuel be pleased to state:

(a) whether it is a fact that the National Coal Development Corporation at Ranchi is maintaining a Courier Service to carry mails to Delhi and Calcutta; and (b) if so, the reasons necessitating maintenance of such a service?

The Minister of Steel, Mines and Fuel (Sardar Swaran Singh): (a) The National Coal Development Corporation at Ranchi is maintaining a Courier service to carry mails to Calcuta, but: no such service to Delhi is maintained.

(b) The Courier service has been introduced for quick disposal of references and sanctions in connection with. tenders, purchase of machinery and colliery stores and Accounts as well. as for the safe movement of files and documents between the Ranchi Officeand the Corporation's Accounts and Purchase Offices located in Calcutta.

(a) the number of Class I and Class II officers in the Manipur-Secretariat whose terms of appointments have been extended beyond one year; and
