## Aircrafts

79. Shri Halder: Will the Minister of Transport and Communications be pleased to state:

(a) whether the aircraft known as Noratlas which is now flying at Dum Dum airport with French registration and insignia of Kalinga Airlines, has been granted a certificate of airworthiness by the Government of India; . . .

(b) whether it is a prototype or series aircraft;

(c) whether there is any proposal by Kalinga Airlines to the Government of India that they may buy that aircraft;

(d) if so, what would be the approximate price of this aircraft including its spare parts; and

(e) the route on which this aircraft is going to operate?

The Minister of State in the Ministry of Transport and Communications (Shri Humayun Kabir): (a) No Sir. The aircraft has since returned to France.

(b) The aircraft was the first of a "Series".

(c) The airline had proposed to purchase a certain number of Noratlas aircraft on deferred payment basis and were advised to submit precise and detailed proposals for the purchase and operation of the aircraft.

(d) The price of this aircraft including spares, etc. is reported to be approximately to Rs. 40 lakhs each exclusive of customs duty.

(e) The proposal of the Kalinga Airlines was to employ the aircraft primarily on International charters.

## Roads in Orissa

**S1. Shri Panigrahi:** Will the Minister of Transport and Communications be pleased to state:

(a) the total amount allotted to Orissa from 1951 to 1955 by the Union Government for construction and maintenance of C.P.W.D. roads;

(b) the total amount allotted for such purposes during 1956-57 and 1957-58:

(c) the mileage of C.P.W.D. roads constructed and maintained in Orissa during 1958-57 and 1957-58; and

(d) what new roads and highways have been included in Orissa under C.P.W.D. in the Second Five Year Plan?

The Minister of State in the Ministry of Transport and Communications (Shri Raj Bahadur): (a) and (b). A statement giving the required information is attached [See Appendix I, annaxure No. 38]

(c) No new roads were constructed by Central Public Works Department during 1956-57 and 1957-58. However, a length of 42:74 miles was maintained by them during 1956-57 but this too was subsequently handed over to the State Public Works Department for maintenance.

(d) Nil.

## Loans to Cultivators in Oriesa

82. Shri Panigrahi: Will the Minister of Food and Agriculture be pleased to state:

(a) the total amount given by the Central Government to Orissa for advancing loans to cultivators during the First Five Year Plan and in the Second Plan period so far; and

(b) for what scheme?

The Deputy Minister of Food and Agriculture (Shri A. M. Thomas): (a) and (b). During the First Plan period a loan of Rs. 133 97 lakhs was sanctioned to Government of Orissa for Grow More Food Schemes but precise information about the amount advanced by the State Government directly to cultivators out of this loan is not available.

During the Second Plan period so far a sum of Rs. 3 28 lakhs has been advanced to cultivators for purchase of agricultural implements and machineries.

## Bridge on Puri-Konarak Boad

**33. Shri Panigrahi:** Will the Minister of **Transport and Communications** be pleased to refer to the reply given to Unstarred Question No. 431 on the 20th November, 1957 and state:
