(g) if not, whether Government propose to give further guidelines to prepare schemes giving individual benefits to tribals ?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI NIHAR RANJAN LASKAR) : (a) Yes, Sir.

(b) Eniphasis is given on incomegenerating schemes directly benefitting tribals as well as on area development schemes.

(c) No, Sir.

(d) A monitoring cell has been created in the Home Ministry. Monitoring and reviewing systems form part of State Governments also.

(e) Special Central Assistance is largely being utilised for beneficiary-oriented schemes.

(f) Guidelines have been issued to the State Governments to weight the planning process in the Tribal sub-Plan in favour of beneficiary-oriented programmes. The guidelines include preparation of Block Plans, Integrated Tribal Development Projects reports and Tribal sub-Plans.
