- (3) Out of 128 pandas squatting in the Yamuna Bazaar area, only those pandas who had to perform actual religious ceremonies in the smasans and bathing-ghats should remain there and the others must be evicted;
- (4) Mochis squatting in the Yamuna Bazaar area should be given training at night classes to make chappals and shoes thus enabling them to earn a decent income on their being shifted to Jhilmila Tahirpur;
- (5) Dhobis, sweepers and other minor personnel squatting in the Yamuna Bazaar area should be housed on plots of land to be made available by the Ministry of Works, Housing and Supply nearabout the New Government Colonies, where quarters for these people should be built, out of the slum clearance funds of the Ministry of Health; and
- (6) The question of re-housing of the railway mazdoors squatting in the Yamuna Bazaar area should be taken up with the Ministry of Railways.
