Survey of Nepal

- (a) whether the Survey of India has taken up the survey of Nepal and production of maps as an assistance to Nepal under the Colombo Plan;
- (b) if so, to what extent the work has been completed;
- (c) the approximate date when the work will be completed; and
- (d) the expenditure that has been incurred by the Survey of India for (i) survey of Nepal and (ii) production of maps?

The Deputy Minister of Education and Scientific Research (Shri M. M. Das): (a) Yes, Sir.

- (b) Out of a total area of 54,000 sq. miles, an area of about 11,000 sq. miles has already been surveyed and survey of a further area of about 4,466 sq. miles is expected to be carried out by the end of the current year 1957-58.
- (c) It is expected that the work may be completed by about the end of the year 1961-62.
- (d) The available information is as follows:—
 - (i) expenditure on survey and mapping upto 31st December, 1957. Rs. 21,29,108.

- (ii) expenditure on aerial photography upto 14th February, 1958 Rs. 24.40.040-61.
- (iii) expenditure on printing upto 31st December 1957.

Rs. 22,999.

Extra Temporary Establishment Services

The Deputy Minister of Defence (Shri Raghuramaiah): (a) No. It has however been decided that 25 per cent. of the Extra Temporary Establishment service, i.e. 50 per cent. of that service which has been equated to temporary service for purposes of seniority, should be counted towards pension subject to a maximum of 5 years.
