- (c) The Special Organising Committee for IX Asian Games 1982 expectse about 5000 players, coaches, interpreters, newsmen, etc., to attend the Asian Games.
- (d) Government have taken the following steps for the training of Indian players expected to participate in the Asian Games 1982:—
  - (1) Comprehensive plans of preparations for Asiad-'82 have been drawn up by the National Sports Federations/Associations concerned, in consultion with the National Institute of Sports. In implementation of these plans, 140 coaching camps have been held up to 31st March, 1982.
  - (2) On the basis of the requests received from the National Sports Federations services of a number of foreign coaches have been obtained to train the Indian feams for Asiad-'82.
  - (3) In accordance with the approved plans, oportunities for the exposure of our teams to international competitions within the country and abroad are being provided at Government cost to the .naximum extent possible.
  - (4) Diet money for players under training for Asiad-82 has been increased to Rs. 25/- per head per day. The players attending camps are also being provided second class rail fare and out of pocket money.
  - (5) The Ministry of Education and Culture has set up a Com-

mittee with Shri Ram Niwas Mirdha M.P., as its Chairman to, monitor the progress of training and coaching of Indian team for participation in the Asian Games.
