Late running of Jayanti Janata Express between Delhi-Muzaffarpur

(b) During January, February and March 1982, 153 UP Jayanti Janata Express reached Delhi on Nii, Nil and 3 days right time out of 9, 8 and 8 days when it ran respectively. 154Dn Jayanti Janata Express Muzaffarpur right fime on Nil, 1 and 3 days each during January, February

and March 1982 out of 9, 8 and 9 days it ran respectively.

(c) Punctuality of these trains is being monitered at Board's level.

Children becoming blind, for want of Vitamin 'A

7394. SHRI G. NARSIMHA REDDY: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

- (a) whether it is a fact that the National Institute of Nutrition has developed an oral dose of Vitamin 'A' to be given to the children at an interval of six months to make up the deficiency:
- (b) if so, whether Government would ensure that not only this produced in sufficient quantity but its price is kept, low, if necessary, through subsidy so that every new-born every hamlet gets the benefit and child blindness is controlled in a big way;
- (c) the other steps Government propose to take in this regard?

THE DEPUTY MINISTER IN THE MINISTRY OF HEALTH AND FAMI-LY WELFARE (KUMARI KUMUD-BEN M. JOSHI): (a) Yes.

- (b) The scheme for free distribution of an oral dose of 200000 International Units of Vitamin 'A' to the children in the age group of 1-5 years in all States/UTs to combat Vitamin 'A' deficiency among children is already being implemented for over a decade by the Ministry of Health and Family Welfare as a part of the Maternal and Child Health Programme. During the Sixth Five Year Plan, 25 million children are proposed to be covered every year. Indigenous production is adequate to meet the requirement.
- (c) Nutrition education among the masses for consumption of low-cost

foods rich in Vitamin 'A' is being promoted though the various health education media.
