THE MINISTER OF STATE THE MINISTRY OF SHIPPING AND TRANSPORT (SHRI SITA KESRI): (a) Yes, Sir.

(b) The Government is examining various administrative, operational and financial measures to reduce the losses. These measures which include among others realistic fare-structure, proper inventory control, fuel, economy, rational route-patterns and easy quick availability of funds are being thought of within the overall policy of rationalisation and with the objective of providing economic transport facilities for commuters all over the country.

Financial assistance for improving the conditions of roads in Madhya Pradesh .

7403. SHRI SUBHASH YADAV: Will Minister of SHIPPING TRANSPORT be pleased to state:

- (a) whether it has come to the notice of the Government that in Madhya Pradesh State, which is surrounded by other States, vehicular traffic of all these States crosses:
- (b) whether it is also a fact that due to the single lane roads in black soil, the traffic jamps up on most of the important routes particularly during the rainy season;
- (c) whether Central Government propose to provide subsidy to Madhya Pradesh Government to improve the conditions of all the roads in that State;

THE MINISTER OF STATE IN THE SHIPPING AND MINISTRY OF SITA RAM TRANSPORT (SHRI KESRI): (a) to (d) The State Madhya Pradesh is connected with adjoining States through a number roads. Among those roads, the Central Government is responsible for maintenance and development of National Highways only. The question of granting any subsidy for National Highways does not arise, All other roads are maintained and looked after by the State Government. In single-lane sections in black cotton soil, where traffic is heavy, some inconvenience to traffic
