**Acquisition of Land Construction  
of Departmental Buildings  
and Staff Quarters in Dehra  
and Una**

2658. PROF. NARAIN CHAND PARASHAR : Will the Minister of COMMUNICATIONS be pleased to state :

(a) whether the Postmaster General, N. W. Circle has taken up the case for the acquisition of 2 plots of land measuring 843 sq. meters and 750 sq. meters at Dehra (Kangra District) and Una, respectively for the construction of Departmental buildings and staff quarters ;

(b) if so, whether the two plots have been acquired and if so, the dates on which the possession has been taken over by the P & T authorities ; and

(c) if not, the date on which the State Government were requested for the acquisition, the latest progress made in the case and the date by which the two plots would be acquired ?

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS (SHRI YOGENDAR MAKWANA) : (a) The Postmaster General, North Western Circle has taken up the case of transfer of two plots of State Government Land measuring 713.65 and 130.95 Sq.

metres for construction of Head Post Office building, Divisional Office building and staff quarters at Dehragopipur in Kangra District. The PMG has also taken up the case of acquisition of a private plot of land measuring 4 kanals 5 marlas for construction of Head Post office building and staff quarters at Una with Himachal Pradesh Government.

(b) The two plots at Dehragopipur have not been transferred and the plot at Una has not been acquired so far. The question of date on which possession was taken of these plots by the P&T Department does not, therefore, arise.

(c) The Dy. Commissioner Kangra Distt. was addressed for transfer of plots of State Govt. Land at Dehragopipur on 27-3-81. But these plots have not so far been transferred. He was last addressed in the matter on 12-2-82. As regard the acquisition of plot at Una, the State Govt. was addressed on 30-1-81. But the plot has not so far been acquired. The State Govt. was last addressed in the matter on 12-11-81. Since decision regarding transfer/acquisition rests with State Govt., it is not possible to give definite date(s) by which the plots would be transferred/acquired.
