of India Ltd., (FCI) was examined by the Ministry, no comparison of its performance with that of the United Catalysts India Ltd. (UCIL) catalyst was carried out.

- (b) The FOI have reported that the condition of the then existing catalyst was deteriorating very fast and there were indications that the catalyst could fail at any time. The FCI therefore processed the case without waiting for the last date for receipt of the offers. Since there were only two suppliers of the catalyst in the country namely, FPDIL and UCIL, both were contacted and technical and commercial offers received from them were evaluated by F.C.I. F.C.I. finally placed a letter of intent on U.C.I.L. on 15-9-1981. F.C.I. has further reported that no procedural irregularities were committed by the Sindri Unit.
- (c) The decision in regard to the use of the catalyst is ultimtely a matter of the technical judgement of the user company.

Expansion of Delhi Telephones
