Goods Train Collision

734. Shri V. C. Shukla: Will the Minister of Railways be pleased to state:

- (a) whether recently, a goods train had collided with a truck at the Supela Railway Crossing near Bhilai, causing death of two persons and seriously injuring another:
- (b) how many such accidents between Railways and motor vehicles have taken place at South Eastern Railway level-crossings between durg and Jamshedpur during 1955, 1956 and 1957:
- (c) how many persons were injured and how many lost their lives in such accidents during the same period; and
- (d) what is the total compensation, if any, paid by the Railways to various affected parties?

The Deputy Minister of Railways (Shri Shahnawaz Khan): (a) The recent accident that occurred at the unmanned railway Level between Supela and Bhilai stations was on 8th December, 1957, when No. 775Up Goods train struck a tractor. There was no casualty.

(b) Seven such accidents took place between Durg and Tatanagar (Jamshedpur) viz.
