The Parliamentary Secretary to the Minister of External Affairs (Shri Sadath Ali Khan): (a) and (b). The Government of India had arranged nine chartered flights to Saudi Arabia by the Indian Airlines Corporation for carrying about 500 Haj pilgrims, with effect from 2nd June, 1958. Due to the prevalence of cholera in India, the Government of Saudi Arabia refused to allow the landing of pilgrims from India by air. The chartered flights had, therefore, to be cancelled. Out of 500 pilgrims, who had booked their passages by air, 250 were anxious and prepared to go by sea. They were accommodated in the last three Haj sailings.

The Deputy Minister of External Affairs (Shrimati Lakshmi Menon): (a) and (b). On the day our Deputy High Commissioner at Lahore was leaving Lahore after the closing down of the Mission on the 10th July, 1958, some persons broke into the house and stole some crockery and ceiling and table fans. The two persons carrying fans were caught and the fans recovered from them. The loss consists of only some crockery pieces. Information about their value is still awaited.

- (c) & (d). Certain members of the staff of our Mission were unduly delayed at the border by Pakistan Police authorities which made them miss the train at Amritsar, causing them and their families considerable inconvenience. Out of the 30 odd persons travelling, 7 or 8 were so detained. The party was detained for over an hour and a half and as their vehicles were also detained some of them had to walk on foot to cross on to the Indian side.
- (e) Protests have been lodged in regard to the two incidents with the Pakistan Government. Their reply is still awaited.
