The Deputy Minister of Labour (Shri Abid Ali): (a) No.

(b) to (d). Do not arise.

## **Import of Films**

\*27. Shrimati Parvathi Krishnan: Will the Minister of Commerce and Industry be pleased to state:

(a) whether a delegation of the South Indian Film Chamber of Commerce met him at Madras on the 21st May, 1958 and submitted a memorandum on the import of films;

(b) if so, what are the demands of the deputationists; and

(c) what steps Government propose to take in the matter?

The Minister of Commerce (Shri Kanungo): (a) Yes, Sir.

(b) The demands of the deputationists were:

- (i) Complete restoration of cut in imports of raw films; and
- (ii) Adequate supply of raw films to meet the minimum requirements of the industry.

(c) As regards (i) it has been noted and will be considered at the time of the review of import policy for the next half year consistent with the amount of foreign exchange that may be available.

As regards (ii) the ratio of distribution of raw films among the production Centres of Bombay, Madras and Calcutta has since been revised to 50:39:11.

## Indo-Pakistan Agreement on Movable Property

•22. Shri D. C. Sharma: Will the Minister of Rehabilitation and Minority Affairs be pleased to refer to the reply given to Starred Question No. 15 on the 11th February, 1958 and state the further progress made if any, in the implementation of the IndoPakistan Agreement on movable property?

The Deputy Minister of Rehabilitation (Shri P. S. Naskar): Some further progress has been made in regard to recovery of buried treasures and exchange of evacuee fire-arms, bank drafts, and lists of movable property. In all other matters, there has been practically no progress; even the meeting of the Implementation Committee which was to be held on the 16th and 17th July, 1958, has been postponed to the middle of October, 1958 at the request of the Pakistan Government.

(b) The accounts of the Institute are audited by Chartered Accountants. No instance of misuse of public funds by the Institute has been brought to notice by the auditors. If any particular instance of inefficiency is brought to the notice of the authorities of the Institute, I am sure they will do their best to rectify matters. I do not think it is necessary for Government to intervene in the internal arrangements of the Institute. Government nominees are members of various bodies of the Institute and important matters are carefully discussed in such bodies. The Institute has grown greatly and has done very commendable work.
