the recommendations made by the Seminar is laid on the Table of the House. [See Appendix I, annexure No. 131.]

- (b) These are under consideration.
- (c) The question of State-wise allocation of funds for village housing for the Plan Period has been, for the present, kept in abeyance pending a decision on the final provision that might become available for this purpose as a result of the re-appraisal of the Second Five Year Plan. A statement showing the funds allocated to various States for this purpose during the current financial year is also laid on the Table of the House. [See Appendix I, annexure No. 132.]

Industrial Estate, Kallai, Kozhikode (Kerala)

- 349. Shri Jinachandran: Will the Minister of Commerce and Industry be pleased to state:
- (a) the present stage of the Industrial Estate at Kallai in Kozhikode District (Kerala); and
- (b) whether any amount has been allotted or paid by the Centre to the State Government for this purpose?

The Minister of Commerce and Industry (Shri Lal Bahadur Shastri):
(a) The State Government have reported that a site has been selected and that they are initiating action for acquiring 10 acres of land in this site.

(b) Proposals for technical approval for the Industrial Estate at Kallai have not yet been received from the State Government.

- (a) the amount of foreign exchange earned by the cinema films during the years 1952 to 1958;
