- (a) the action taken on repeated complaints and representations made by the passengers and general public about the insanitary condition of compartments which run without electric lights, fans and water on the branch line from Sambalpur to Jharsuguda on the South Eastern Railway; and
- (b) the number of First and Second Class Coaches running on the branch line?

The Deputy Minister of Railways (Shri Shahnawax Khan): (a) There have been two complaints on train lighting since March 1958. Arrangements have been made to instal a battery charging plant at Jharsuguda to ensure satisfactory lighting on this branch line.

The single rake serving this 30-mile branch line is thoroughly washed, cleaned and watered at Jharsuguda and drycleaned at Sambalpur between trips each way.

(b) One composite First, Second and Third Class bogie of seating accommodation;

1st Class—8 berths or 12 seats 2nd Class—12 seats.

The occupancy is 24 per cent. for 1st Class and 5 per cent. for 2nd Class.
