717. **Shri Raghunath Singh:** Will the Minister of Finance be pleased to state whether it is a fact that the Bombay Customs authorities in the course of a search of Cross Island on the 11th July, 1958 seized American cigarettes which were purchased from the members of the crew of SS "TIMAVO"?

The Minister of Finance (Shri Morarji Desai): Yes, Sir. On 11th July, 1958, the Preventive Staff at Bombay intercepted a 'Tony' coming from Cross Island. The occupants of the 'Tony' confessed to having dumped on the island, some bundles of American cigarettes which they had purchased from the crew members of SS "TIMAVO". A search of the island resulted in the find of six cloth bundles containing in all 429 cartons of American cigarettes 200 cigarettes to a carton. The cigarettes have been confiscated and suitable action has also been taken under the Sea Customs Act against the crew members concerned of SS "TIMAVO".
