

and seventy-four thousand only), representing two-thirds of the estimated expenditure to be incurred by the Government of Kerala on increasing the emoluments of low-paid employees of the State Government and Local Bodies and teachers in private primary schools, was sanctioned by the Ministry of Finance during 1957-58. The grant is subject to final adjustment on the basis of actual entitlement.

(b) One-third of the total expenditure

(c) The expenditure involved in sanctioning the increases in emoluments will have to be incurred by the State Government in full in the first instance. Thereafter the Government of India reimburses its share of the expenditure, subject to the conditions laid down for the grant of Central assistance being fulfilled.

The Minister of Steel, Mines and Fuel (Sardar Swaran Singh): (a) The total amount sanctioned so far for the purchase of machinery for the Neyveli Lignite Project is about Rs. 740 lakhs.

(b) The value of machinery for which orders have been placed so far is about Rs. 669 lakhs.

Shrivastava): (a) and (b) The grant of 20,000 dollars has not been made to the University of Delhi, but to the Delhi Training and Orientation Centre for foreign technicians in India which functions under the guidance and supervision of the Delhi School of Economics Society and provides Orientation courses for these technicians.
