THE MINISTER OF STATE IN THE MINISTRIES OF AGRI-CULTURE AND RURAL DE-VELOPMENT (SHRI R. V. SWAMINATHAN) (a) Sugarcane is mainly grown in Surat, Bulsar, Amreli, Junagadh and Rajkot districts of Gujarat.

(b) The production of sugarcane in Gujarat during 1978-79, 1979-80 and 1980-81 was 32.87, 31.92 and 44.35 lakh tonnes, respectively.

(c) Measures being taken to increase the production of sugarcane in Gujarat State are:

- (i) Supply of improved seed;
- (ii) Aerial spraying against the pest pyrilla;
- (iii) Carrying out demonstrations of improved techniques of crop cultivation;
- (iv) Imparting training and guidance under Training & Visit Programme; and
- (v) Intensification of research efforts.
