The Prime Minister and Minister of External Affairs (Shri Jawaharia) Nehru): (a) to (c). The only area affected by recent incursions and firings by Pakistan forces in Tripura is village Lakshmipur. On the night of 6/7th August, 1958. Pakistan armed forces raided the Indian Police Outpost in this village and opened indiscriminate firing. As a result of this, two Indian Police personnel were killed and two injured. Three of them, including the Commandant, were kidnapped to Pakistan and are now in detention of Pakistan authorities. The Government of Pakistan has been asked to release them.

(d) The persons directly affected by the raid were the police personnel mentioned above. The size of the civilian population disrupted or otherwise affected adversely is not known but could not be large. Information about measures taken by the Tripura Administration for the relief given to them or their families is not yet available

Tukegram Village Occupied by Pakistanis
