THE DEPUTY MINISTER IN THE MINISTRY OF FINANCE (SHRI JANARDHANA POO-JARY): (a) to (c). Agricultural Refinance and Development Corporation (ARDC) does not provide refinance assistance, generally, for purely agro-industrial loans. Where, however, the manufacturing processing is an integral part of the total agricultural development project, refinance assistance is given by ARDC for this purpose also. Disbursements by ARDC for major agro-industrial components financed as part of the project of agricultural development or development of allied sectors during the last three years were of the order of Rs. 82 lakhs.

It is not possible to estimate the total demand for term credit for such agro-processing units. Each case is considered on its own merit and refinance assistance is provided keeping in view the cost of investment, or escalation in such costs where justified,

Posting of Assistant Directors/ Managers of Tourism Department abroad

9356. SHRI QAZI SALEEM: Will the Minister of TOURISM AND CIVIL AVIATION be pleased to state:

- (a) whether it is a fact that fifteen Assistant Directors/Managers in the Department of Tourism are being posted abroad shortly;
- (b) what are the criteria for considering posting of the officers abroad in the Department;
- (c) whether it is also a fact that Jr. Officers promoted on ad hoc basis have been favoured to be sent abroad ignoring the claim of the senior officers; and
- (d) if so, the reasons therefor and particulars of such officers and

the basis on which they have been considered as such?

THE MINISTER OF STATE IN THE MINISTRY OF TOURISM AND CIVIL AVIATION (SHRI KHURSHED ALAM KHAN): (a) Yes Sir, Orders of transfer of 15 Assistant Directors/Managers Overseas Tourist Offices were issued on 12-2-1982. Out of the said 15 officers, one has declined posting in an office in Europe for personal reasons.

- (b) The following guidelines have been laid down for selection of officers for posting abroad:-
 - (i) Officers are posted to overseas assignments in order of suitability-cum-seniority, with due emphasis on suitability.
 - (ii) The period of posting abroad would normally be 3
 - (iii) An other who has aiready had a posting overseas would become eligible for further posting abread only after completion of three years' stay in India in the case of Deputy Director General/Regional Director and above, and 5 years in the case of other levels offictrs.
 - (iv) Those officers who have never been posted abroad or have been in India for a longer period, would be given due preference if otherwise suitable.
 - (v) SC/ST officers are given due consideration.
- (c) Selection of officers for posting abroad has been made as per guidelines laid down therefor from amongst officers available at the time decision was taken in the Ministry. No favour/discrimination has been shown to any one in this regard.

(d) The following Assistant Directors/Managers, who are officiating on ad-hoc basis in the

grade are included in the list of officers selected for foreign posting:
