9357. DR. A. U. AZMI: SHRI RAJNATH SONKAR SHASTRI:

Will the Minister of FINANCE be pleased to state the progress made in the case of evasion of income tax by M|s. Continental Construction Co. Ltd. together with steps taken to go through all the transactions thereof?

THE MINISTER OF STATE THE MINISTRY OF FINANCE (SHRI SAWAI SINGH SISODIA): The investigations are still in progress.

New item captioned "US wants. World Bank to follow its line more directly"

9358. SHRI B. V. DESAI: Will the Minister of FINANCE be pleased to state;

(a) whether Government's atten tion has been drawn to the 'Hindu' dated 1-3-1982 under the heading "US wants World Bank

to follow its line more directly" in which it has been reported that the Reagan administration determine to make multilateral institutions such as the World Bank follow the US line more directly among other things by implementing a plan for the maturation of borrowers (such as India and China) out of the "soft loan window":

- (b) if so, whether as per these reports, US is influencing World Bank not to give more loan to India and also put a pressure for getting the same;
- (c) if so, the reaction of the Indian Government:
- (d) what steps are being consi dered by India; and
- (e) whether concern has been conveyed to US over reduction of aid flow?

THE MINISTER OF FINANCE (SHRI PRANAB MUKHERJEE): (a) Government have seen a report entitled "US wants World Bank to follow its line more directly" which appeared in the 'Hindu' of March 1, 1982.

(b) The Treasury Department of the United States recently reviewed the United States approach to multilateral development institutions. According to a report, released by the U.S. Treasury the approach of the United States to the question of maturation of borrowers is that there is considerable scope for improving the implementation of the maturation policy, particula !ly with regard to the weight that each criterion for maturation like per capita income, creditworthiness and performance should have in the maturation process. U.S. Administration feels that with a view to achieving greater efficiency in allocation of IDA funds, blend countries with better resource base and creditworthiness should be closely examined as potential candidates for maturation even though their per capita incomes are relatively low.

- (c) Government of India are of the view that multilateral institutions should function on the basis of objective criteria such as per capita income in allocating their resources to developing countries.
- (d) and (e). Government of India's concern over recent trends affecting the functioning of the World Bank has been made clear in various fora.

वित्त मंत्री (श्री प्रणव मुखर्जी) : (क) अमेरिकी अन्तर्राष्ट्रीय विकास अभिकरण ने मध्य प्रदेश सामाजिक वनपालन परियोजना के लिए अब तक 140 लाख डालर की सहायता दी है जिसमें से 130 लाख डालर ऋण के रूप में 10 लाख डालर अनदान के रूप मों दिए गए हैं।

(स) इस ऋण की वापसी अदायगी 10 वर्ष की रियायती अविध सहित 40 वर्षों में की जाएगी और इस पर पहले 10 वर्षा में 2 प्रतिशत वार्षिक और उसके बाद 3 प्रतिशत वार्षिक की दर से ब्याज लगेगा । जनदान की वापसी अदायगी नहीं की जाएगी ।

THE DEPUTY MINISTER IN THE MINISTRY OF COM-MERCE (SHRI P. A. SANGMA): (a) The main objectives of the Hindustan Dimond Company Ltd. are, inter alia, to assist the indigenous industry by procuring rough diamonds and precious stones, to help in upgradation of outing and polishing of stones and to carry on study and research aimed at developing export trade of diamonds.

(b) An International Lapidary Exhibition was held at Jaipur in March, 1981, by the Gem & Jewellery Export Promotion Council in collaboration with the Hindustan Diamond Company Ltd.
